#### BACKGROUND:

The Philippine Department of Tourism (DOT) will be conducting the PH Mega Familiarization Tour for UK Media and Tour Operators on November 21-30, 2022 and November 25-Dec. 5, 2022 respectively. The media group will be composed of five (5) media personalities/ companies while the tour operators' group will be composed of five (5) UK-based tour companies. This project is the second leg of the Joint Marketing and Promotion Project with Turkish Airlines.

#### I. PURPOSE / OBJECTIVES

The Department of Tourism (PDOT) needs the services of a UK-based, licensed transportation supplier that will provide the transport service requirements of PDOT London for the PH Mega Familiarization Tour for UK Media and Tour Operators.
